

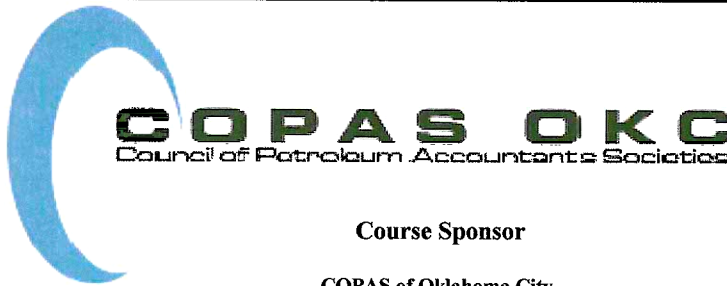

The COPAS Tax Committee for the Oklahoma City Society is now accepting applications for the 2008-2009 year. We want to encourage all current members to renew their membership for the coming year. If you are not currently a member, we have mailed this invitation as a recommendation from one of our active members. Eligibility for membership follows the COPAS requirements which is open to all persons actively working in the field of Accounting, Finance and Economics with companies or entities that are directly or indirectly engaged in exploration, production, refining, marketing or transportation of oil and gas. Our committee has been approved by the Oklahoma State Board of Public Accountancy as a sponsor of continuing education and offers continuing professional education credit for most of our monthly meetings.

Meetings will be held monthly on the third Wednesday of each month at 11:30a.m. from September thru May, unless otherwise noted on the monthly notice. Tentatively, our meetings will be held at Jazmoz Bourbon Street Cafe in Bricktown. This will give the people working downtown easier access to our meetings. Please look each month at the meeting notices to verify when and where it will be held.

We are pleased to announce that dues are *not* being increased this year. Membership dues are for the period September 1, 2008 through August 31, 2009, which is consistent with that of General COPAS. Members of the Tax Committee, who are not members of General COPAS, are required to pay \$50.00, which is remitted to National COPAS. If you previously paid the \$50.00 dues to General COPAS (i.e., are a member of and attend General COPAS) your payment would only be \$190.00. Your payment will cover the cost of nine lunch meetings and dues.
